**Subject:** Sample Ballot Paper for conduct of 2<sup>nd</sup> Membership Verification of Executives through secret ballot on 18.08.2020-regarding.


Please find enclosed a copy of finalized sample ballot paper of the eligible Associations which will be participating in the 2<sup>nd</sup> Membership Verification process with the following instructions:

1. The Circles shall make necessary internal arrangements for printing of ballot papers instead of from press, thereby curtailing the expenditure.
2. Each ballot paper shall have a counter foil at top separated by perforation mark as shown in the sample paper annexed.
3. Ballot papers shall be printed with distinct running Serial Number in accordance with the staff strength of the Circle concerned. The distinct Serial Number shall be available only on the counter-foil for account purposes, In other words, the counterfoil, and not the ballot paper, should bear the serial number.
4. Sufficient number of ballot papers ( say about 10% more than required) may be printed to account for contingencies of the ballot papers getting inadvertently spoiled or crumpled or torn during handling in the actual process of conduct of Membership Verification.
5. Ballot paper shall be printed in black and white.
6. Ballot paper shall be printed only on one side of the paper.
7. Order of the Associations shown in the Sample paper shall not be changed i.e. the S. No of the Associations will remain the same as shown in the approved sample ballot paper.
8. Height of the rows allotted to every Association should be the same and uniform.
9. All the rows shall be separated from each other and from the title row by a distinct dividing line.

10. Because stamp shall be affixed by the voter inside the Seal box against the Association, size of the box therefore should be sufficient to accommodate the "SWASTIC" stamp comfortably without crossing the dividing line.
11. It is requested that the action for printing & distribution of Ballot Papers may be taken.
12. A replica of the Ballot Paper shall be prominently displayed on the Notice Boards and published/uploaded on the official websites with the following instructions to Voters –
  - a. Please put the stamp in the Seal box.
  - b. Please put the stamp against only one Association in the seal box against the Association name, the voter wants to vote for.
  - c. Please do not write any message, name, signature or any type of indication on the ballot paper.
