**Subject: Promotion/Posting in the grade of Accounts Officer - regarding**

Kindly refer to this office Promotion/posting orders No 3-41/2011 SEA BSNL dated 15-01-2015 and 16-1-2015 vide which Junior Accounts Officers/Assistant Accounts Officers were promoted to the grade of Accounts Officer subject to clearance from Vigilance angle. Moreover, for timely implementation of the above orders, a clarification was issued vide this office letter No 3-41/2011 SEA BSNL dated 23-01-2015, wherein circles were directed to furnish a consolidated statement showing implementation status, in respect of individual executive and vacancy position in the grade of Accounts Officer to this office. Necessary compliance report from circles is still awaited.

In this connection, it is stated that due to non-availability of vacancies in the grade of Accounts Officer in many circles, some of the executives have been adjusted against the vacant posts in deficient circles as per the need of the Company. However, it has been noticed that many of these executives have given representation for accommodating in the circle, where they are presently posted or requesting for their transfer to some other circle as per their choice. Many such requests have been received in BSNL CO directly.

Due to administrative exigencies, it is not feasible for Management to consider all the requests of the executives for retention / re-allotment in the circle as per the choice of the executive, after promotion to the grade of Accounts Officer. Only those cases, which deserve consideration due to its specific nature and which are duly recommended by the Competent Authority of concerned circle shall only be considered on case to case basis, at BSNL CO, subject to availability of vacancies in the grade of Accounts Officer in the concerned circle. Assessment of vacancies may be made, by taking into account the executives under orders of transfer from other circles, after implantation of promotion orders. In the event of consideration of request of any executive for his/her retention favourably, equal number of executive shall be withdrawn from the concerned circle in the grade, to maintain equilibrium in vacancies.

All the concerned circles are therefore requested to implement the promotion orders first irrespective of their posting after promotion (i.e within the circle or outside the circle) and in respect of those executives who have been transferred to other circle (s), they should be relieved immediately to the circle of posting on or before 06-02-2015 positively as already mentioned in para 4 of the promotion orders.

This issues with the approval of the Competent Authority.
