Subject: Seeking immediate intervention for affecting relief of CAOs under order of transfer - regarding.

Kindly refer to instructions issued by Corporation Office from time to time for relieving of executives who are under orders of transfer to various shortage circles.

On review of records, it has been observed/found that inspite of specific instructions issued from BSNL CO, the following executives in the grade of CAO have not been relieved so far, from your Circle or have not joined the assigned Circle. As a result of which executives who have completed their stipulated stay/tenure in the circles (including tenure circles in some cases) are held up due to non-joining of executives/substitutes who have been transferred particularly from Assam, AP,UP East and Karnataka Telecom Circle.



Sufficient period of time elapsed since transfer orders have been issued in some cases. Due to superannuation/voluntary retirement in the grade of CAO and also by the promotion of CAOs to the grade of DGM (F) during the intervening period, shortage in the grade of CAO has increased in almost all the circles. However, BSNL CO is seized with the problem and necessary action already been initiated to fill up the vacant posts in the grade of CAO in the circles. However, till the time these posts are filled up by BSNL CO, work of vacant posts in the grade of CAO may be managed from internal resources, by making look after arrangement locally as per standing instructions.

All the transfer orders in the grade of CAO mentioned above may be implemented without any further delay and that also latest by 13.7.2014, if not already implemented. Failing which, their relieving orders shall be issued by BSNL CO itself.
