2. The executive(s) who is/are transferred above, in case, is/are looking after in a higher grade locally, the arrangements should be terminated before relieving him.


3. No leave should be granted to the executive(s) who are re-allotted in this order by the circle from where executives are re-allotted under any circumstances.
