Please refer to my D.O. letter of even number dated 29-10-2013 and subsequent reminder dated 18-02-2014 regarding settlement of pending Pre-2006 CDA pension revision cases.

2. It is seen from the latest pendency status submitted to me (copy enclosed) that although a substantial reduction in the pendency figures has been achieved by the circles in the last four months, complete liquidation thereof is still a long way off.

3. As you may be aware that the DoT at its senior-most levels, is pressing hard for early settlement of pending cases, you may have to monitor the matter personally and ensure liquidation of all pending cases by taking all possible steps, **positively by 31-03-2014.**
