Respected Sir,

On the subject and reference cited above, in continuation to our letter dated 31.08.2017, copy attached for ready reference, we would like to bring to kind notice that Rajasthan Circle of BSNL has revised the pension / pay without the getting the endorsement of the letter under reference above from BSNL Corporate Office.

It is worthwhile to mention here that Hon'ble CAT Bench Jaipur of Rajasthan State has granted stay order for pay revision and any recoveries till the next date of hearing i.e. 05.10.2017. While passing the interim order Hon'ble CAT has categorically mentioned that-

"I have carefully gone through the prayer for interim relief.

Considering the fact of the case, the prayer for interim relief seems to have merit. Accordingly, in pursuance of the impugned order pay revision and any recoveries following this pay revision shall remain stayed till the next date of hearing. If, however, the respondents feel that the facts and circumstances are otherwise than what is stated by the applicant, they are at liberty to move for the amendment of this order."

Even though, Rajasthan Circle is implementing the DoT order dated 05.07.2017 and revised the pay of retiring officers and made the recoveries from leave en cash payment of the retiring officers.

A copy of the letter jointly given by CS of AIBSNLEA and SNEA is attached herewith for your kind perusal.

In view of this, we would like to request you to kindly intervene in the matter and issue necessary instruction to CGMT Rajasthan not to implement the said DoT order till the time DoT reply to BSNL Corporate Office is received and the stay order granted by Hon'ble CAT Bench Jaipur is vacated to avoid contempt of court.
