Respected Sir,

We would like to draw your kind attention on the above cite subject. In pursuance to the instructions contained in the above cited BSNL Corporate Office letter reporting structure of East Zone Nodal Centre has been changed from West Bengal Telecom. Circle to Kolkata Telephones District with immediate effect.

In this regard we would like to submit the following points for your kind information and consideration please.

1. More than 125 Executives are working in the East Zone Nodal Centre under West Bengal Telecom Circle.
2. No options have been called for from the Administration before changing the reporting structure.
3. No detailed guidelines have been issued by the BSNL Corporate Office in this regard.
4. Executives working in East Zone Nodal Centre are very much disappointed and felt that this Merger is against the Natural justice.
5. In this connection, kindly find enclosed herewith a detailed letter received from the Circle Secretary, AIBSNLEA, West Bengal Circle.

6. It is learnt that West Bengal Circle and Kolkata Telephone District have taken decision for the total merger and it was also decided that Salary and other payments of BA EZNC to be paid from K.T.D. w.e.f. 1.4.2019.

In view of the above, we would, therefore, request you to kindly intervene in the matter and cause to issue necessary instructions to the Officers concerned to cancel the orders of reporting structure of East Zone Nodal Centre from west Bengal Telecom circle to Kolkata Telephones District.
