**Subject: Conducting CPCs for promotion and filling-up of the vacant SDEs/DEs/AGMs/AOs/CAOs posts considering SC/ST Roaster implementation as per the DoP&T guidelines.**

**Respected Sir,**

On the subject cited above, kindly refer to this Association letter of even number dated 12.05.2016 and 30.05.2016 wherein it is requested to fill-up about 2000 posts of DEs/AGMs in Telecom Operations stream and about 900 posts of Chief Accounts Officers at the earliest. These CPCs have been stalled due to an Interim Order issued by Hon'ble CAT, Chandigarh Bench in the OA No. 060/00295/2015 & MA No. 060/01324/15 dated 14.03.2016. It is worthwhile to mention that Hon'ble court has not granted any stay order on the CPCs.

It is understood that the Management after taking the legal advice has now decided to file an appeal in the Hon'ble High Court of Punjab & Haryana against the aforesaid judgment of Hon'ble CAT Bench Chandigarh and to get impleaded in the SLP pending in the Hon'ble Supreme Court of India in the matter of Laxmi Narain against the judgment of Hon'ble High Court of Punjab & Haryana.

In view of the above, it is requested to kindly take immediate steps for filing the appeal in the Hon'ble High Court of Punjab & Haryana as well as implead in the SLP pending in the Hon'ble Supreme Court of India in the matter of Laxmi Narain against the judgment of Hon'ble High Court of Punjab & Haryana.

It is also requested to kindly initiate the CPCs to fill-up about 2000 vacant DE posts and about 900 CAO posts immediately since there is no stay order on promotions. The CPCs can be conducted by implementing SC/ST roaster as per the available DoP&T guide lines.

An urgent action in this regard is solicited please
