O R D E R

Subject: - Promotion and posting of the DE/ AGM to the grade of DGM (Pay Scale of 32900-58000) in Telecom Operations Stream on purely on temporary and adhoc basis.

The following **119** DE/AGM of Telecom Operation Stream are hereby promoted to the DGM Grade of Telecom Operations Stream in the scale of pay of 32900-58000 [IDA revised] on purely temporary and adhoc basis with immediate effect and until further orders. On promotion the executives are posted as per Annexure.

2. The Executives would not have any claim for their seniority/regular service in DGMS Grade of Telecom Services based on this adhoc promotion. Their seniority will continue to be determined with reference to their basic seniority in the substantive grade of DEs/AGMs of Telecom Service (STS Level).

3. This promotion order will, however, not be effected by the concerned Circle/Units in case:

- i. Disciplinary/vigilance case is pending.
- ii. The officer is under the currency of any penalty.
- iii. The officer is on deputation to TCIL etc.
- iv. P.O. not issued due to any reason.
- v. Ad-hoc promotion orders already issued earlier by DoT/BSNL.
- vi. Due to any direction from Hon'ble Court/CAT for not effecting the promotion to an individual.

All the cases covered under the above categories may be forwarded within 15 days from the date of issue of this order to this office for taking appropriate action.

4. The promoted Executives are directed to join their new promotion assignment within 40 [forty] days. The CGM concerned may ensure that the station of posting order in respect of the officers are issued in time and such officer are relieved accordingly so as to enable them to join the assignment within a prescribed time period of 40 days from the date of issue of this order.

In case, the officer concerned failed to join their new promotional assignment within the prescribed time period of 40 days, he should not be allowed to join the post thereafter. In such an event the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action. Further, no request for the modification of promotion/posting orders shall be entertained after the expiry of the 40 [forty] days period.

5. The leave, if any requested by the officer, who is under transfer, should not be allowed. If, any officer desires leave, he can apply for leave to the Competent Authority only after joining the new posting and the Competent Authority will sanction leave, if it is considered justified, in the normal course.

6. The Executive who is under transfer to any other Circle as DE, he may be directed to join as DGM on promotion in the Circle where he has been ordered for his transfer in the grade of DE. Details of such cases be forwarded to the Corporate Office.



9. This issues with the approval of the Competent Authority.


