We would like to inform you that one of our CHQ office bearer Sri S.K. Jena working as SDE(C) at Bhubaneswar in Odisha Circle is under transfer to NE-II. Both from association and administration point of view his stay at Bhubaneswar is very much required. His contribution towards procurement of external project is immense and considering his suitability for management of external works he was retained in Odisha Circle up to 31<sup>st</sup> March 2018.
