**Subject Deduction of Premium towards GTI (Group Term insurance) - Withdrawal from
the Scheme-reg.**

Reference BSNLCO Trg. Cell-Lr No. 8-1/2017-Restg (Pt-II) dated 27th Feb 2019

Respected Sir,

We would like to draw your attention on the above subject. In this regard we wish to submit that in Tamil Nadu Circle, totally 768 Executives have opted for GTI scheme [665 Executives with Age below 50 years opted for GTI (50 Lakhs Policy), 60 Executives with Age above 50 years opted for GTI Scheme-I (50 Lakh Policy) & 43 Executives with Age above 50 years opted for GTI Scheme-II (20 Lakh Policy)

In this connection, **it is intimated that 45 Executives as listed in Annexure-I have given representations to opt out of the scheme citing various reasons such as they have inadvertently opted for Voluntary GTI through ESS Portal / representation already submitted but not updated in ERP / want to opt out now / due for retirement on 31.03.2019 etc., Accordingly they have requested not to deduct the premium towards GTI in their monthly salary.**

In this regard, it is intimated that the access to update the GTI option in ERP backend has not been provided to Circle/SSA DDOs. Hence, the updation to Opt-out of GTI could not be done in SAP by concerned DDOs based on the representation submitted by some Executives during Dec-2018 to Feb-2019. Also in 17 cases after effecting the GTI recovery, the Take Home Pay becomes Negative.

In view of the above, it is therefore requested to approve withdrawal from the GTI Scheme for the executives mentioned in Annexure-I and issue necessary instructions to the concerned not to deduct the premium from the Pay of March-2019 in respect of these executives..

In this regard letter received from Circle Secretary, TamilNadu circle which is self explanatory, a copy of the letter addressed to GM (CA), BSNL Corporate Office, New Delhi by PGM (Finance) TN Circle and a copy of the letter addressed to Sr.GM (Estt), BSNL Corporate Office, New Delhi by GM (HR & Admin) TN Circle copies of representations received from the executives in Annexure I, are also enclosed herewith for your ready reference.
