Respected Sir,

This is with reference to the Transfer & Posting ORDER No. 412-20/2014-Pers I dated 25TH November, 2014. Out of the 15 cases recommended by CGM, CHENNAI TELPHONES, revised posting to **CHTD was permanently** given to seven DEs. Three Executives have declined promotion. The remaining Five DEs, are retained in Chennai Telephones only upto 31.05.2015 .

Chennai Telephones is facing acute shortage of Divisional Engineers and number of DEs have declined promotions due to family circumstances and the morale of the executives is very much down due to 'transfer threats' at the fag end of their career. This has resulted in sizeable executives taking VRS due to compulsions. This has also badly affected the performance of CHTD.

The following officers are retained up to 31/05/15:

- She is a **spinster** and completing **58 years on 31/07/2015** and attains superannuation in July 2017. She is a chronic Vertigo patient and often faint which needs immediate treatment and support from her family.
