- (a) Concession of immunity from transfers from the Headquarters of recognised Unions/Associations is applicable to their office bearers during the first year of their elections to the offices of Chief Executive or General Secretary, Asstt. Secretary and Financial Secretary, (or Treasurer) of Class III or Class IV Union whether they are All India, Sircle Divisional or Branch Unions (if the constitution and by-laws of the Central Union permit opening of such branches);
 - (B) If there are several office bearers with the same desi nations, the concession applies during the first year of the office to only one of each category, i.e. Chief Executive or General Secretary, Secretary, Assistant Secretary and Financial Secretary (or Treasurer) as may be nominated by the Unions;
 - (c) The concession causes to be applicable to the above Union office bearers on promotion to higher posts :
 - (d) With the mutual goodwill between the Union and the local officers and subject to the administrative concenience, the office bearers elected to above said offices of the Union may stay at the Headquarters station even longer than one year ;
 - (e) If the office bearers working at other stations are elected to these offices, i.e., Chief Executive or General Secretary, Secretary, Asstt. Secretary and Financial Secretary (or Treasurer) they may be brought on temporarily transfer to the headquarters of the Union during the first year of election

(g) the concessions are not guaranteed and cannot be claimed as a matter of right. They are always subject to administrative exigencies.

The orders regarding coant of immunity from transfers to Union office beerees should be followed strictly except on administrative grounds. Bringing the Chief Executive of the Unions to their Headquarters should also be followed if an appropriate post in which the Chief Executive could be posted, is available.

Where it is not possible to observe the general principles laid down in the instructions on the concession of immunity from transfer, a report should be sent to the Directorate indicating the circumstances under which it is not possible to extend the facility even in the first year of term of office with the Union.

In RMS where the Divisional, Circle or All India Secretaries cannot be posted at the headquarters, there is no objection to grant requests for posting of Divisional Circle and All India Secretaries in RMS Sections to enable them to come to their respective administrative headquarters. This is subject to administrative convenience.

Subject to administrative exigencies, this concession of immunity from thansfer may be granted for the 2nd year also to the office bearers of such of the Associations/Unions whose constitution provides Conference/Elections in two years, instead of annually.
