Sir/Madam,

A provisional seniority list in respect of STS regular Executives of Telecom Finance working in BSNL, as on 15.4.2010 is hereby forwarded (annexure) with a request that the same may be brought to the notice of all concerned.

2. The seniority list may be circulated among all concerned under acquaintance. Representations regarding discrepancy of seniority, if any, noticed in the provisional seniority list may be forwarded to this office in one bunch with requisite authenticated supporting documents and also with comments of the circle so as to reach this office on or before 31.05.2010. Representations received directly but not through proper channel and / or received after 31.05.2010 or representations received without supporting documents will not be entertained at this end.

3.1 The seniority in respect of executives mentioned at Sl no. 1 to 8 of this provisional seniority list has been taken from the seniority list of officers in the grade of STS of IP&T AFS, Group 'A' issued by DoT vide letter no. 33-25/2004 SEA I dated 9.2.2005.

3.2 Executives in Sr. AO/STS(A) promoted/regularised as STS in Telecom Finance on regular basis from amongst the seniority list of Sr. AOs circulated by DoT vide order no. 53-1/2001 SEA II dated 6.5.2003 has been taken next in their order of seniority in the Sr. AO seniority list. After exhausting the Sr. AOs from the list mentioned above, in respect of executives belonging to ST Category, who have been regularised/promoted to STS of Telecom Finance on regular basis in BSNL, the provisional seniority list of Sr. AOs/AOs floated by BSNL vide no. 3-23/2008 SEA BSNL dated 27th May, 2008 has been taken as the basis.

4. The points that need your attention are:

- i) The particulars furnished in all the column(s) may be verified and necessary correction, if any, may be intimated.
- ii) In case, the official against whose names the word "OC" or "SC" or "ST" have been wrongly indicated and required to be modified the factual position may be verified from the service records of the official and confirmed.
- iii) The date of assumption of charge on promotion of the Executives to STS on regular basis with reference to Col 7 may be informed for further necessary action.
- iv) It may be checked whether name of the officers who have already been promoted to the higher grade / who have retired / voluntarily retired / expired / whose promotions has been withheld at the circle level /absorbed elsewhere permanently / not in service / not absorbed in BSNL or any other reason are included in this seniority list. In such cases, a separate list may be got prepared and sent to this office.
- v) Any name to be added or to be deleted or names to be corrected may also be checked up and intimated along with reasons therefore.
- vi) Missing particulars in the columns viz. date of birth, date of entry may please be supplied to this office.

5. Corrections /changes /insertions to be made in the list along with missing particulars in the seniority list etc. may be sent so as to reach this office by 31.05.2010 in one lot.
