As Per letter No.1-9/2012 (A&P) dated 08.08.2012 TRAI has sent an offer of appointment to the following executives who have been selected to the post of Senior Research Officer in the TRAI regional offices mentioned below on deputation on foreign service terms, initially for a period of two years from the date of taking over the charge of the post or until further orders whichever event takes earlier:-

The officer will be governed by the pension and leave rules as followed in the BSNL but for his deputation with TRAI.

The officer will be entitled to medical facilities which shall not be inferior to those which would have been admissible to him in BSNL. The expenditure will be born by TRAI.

Incidence of compensatory allowances for the period of leave during or at the end of foreign service :

The whole of the expenditure in respect of any compensatory allowances for the period of leave during or at the end of the foreign service shall be borne by the TRAI.

10. Provident Fund:

While on Foreign Service, the officer will continue to subscribe to the Provident Fund to which he was subscribing at the time of proceeding on Foreign Service in accordance with the rules of the fund.

11. Leave Travel Concession:

The officer will continue to be entitled to LTC as per Ministry of Home Affairs OM No.43-1/55 (ii)/ Part (II) dated 11.10.56 as amended from time to time and the cost thereof will be borne by the TRAI.

12. Insurance Scheme:

During the period of deputation, the officer will continue to be governed by the GSLI Insurance Scheme of the BSNL. The TRAI will ensure that the deductions made towards the GSLI are sent to the concerned A.O.

13. Residential accommodation:

He will be entitled to residential accommodation according to the rules of TRAI.

14. Other facilities :

As admissible to the officers and employees of TRAI.

15. The deputation can be terminated from either side i.e. by the TRAI or the official with one month prior notice.

TERMS & CONDITIONS

1. Period :

The deputation is initially for a period of two years. The deputation will commence on the date the officer relinquishes charge of his post under the BSNL and end on the date he resumes charge of his post under BSNL.

2. Pay and Allowances :

The pay and allowances of the officer during the period of deputation will be regulated in accordance with the provisions laid down in the Ministry of Finance OM No.F.1 (II) –E.II (B)/75 dated 7.11.1975, as amended from time to time.

3. TA & Transit Pay:

The TRAI will bear the cost of transfer, traveling allowance of the officer including his family (as defined in SR-2) in respect of the journey for joining the TRAI as also for the journey to join his post in the BSNL on the termination of his service with the TRAI in accordance with the rules of the TRAI on the subject. While on deputation the officer will draw TA in respect of his work with the TRAI under the TRAI Rules. The TRAI will also pay to the officer his joining time pay by both ways, the joining time being regulated under the Central Government Rules.

4. HRA & CCA:

While on Foreign Service, the grant of HRA and CCA to the officer will be governed by the Ministry of Finance O.M. No. 2(21)-E-II/68 dated 15.11.1968 as amended from time to time.

5. Leave Salary and Pension Contribution:

The TRAI will pay to BSNL Leave salary & Pension contribution at the rates in force from time to time in accordance with the orders issued by the President of India under FR 116 and 117 for the period of Foreign service. The pension contribution is to be calculated based on the maximum of the pay scale and subject to further orders issued by the Deptt. of Telecom, in respect of BSNL. The officer will not be allowed to join any pension scheme of the TRAI. The officer will be governed by the leave rules as followed by BSNL but for his deputation with TRAI. TRAI will pay the Leave Salary contribution and Pension Contribution by 5th of the following month at the rates notified by the concerned circle/unit who will be responsible for watching recovery of the amount in time. The contributions should be paid promptly subject to the adjustment and alterations in accordance with the final rates to be intimated by the concerned circle/unit. The penal interest will be leviable for delay in accordance with the provisions of the rules.

6. Disability leave and leave salary :

The TRAI will be liable to pay leave salary in respect of disability leave granted on account of disability, if any, occurred in and through foreign service even though such disability manifests itself after the termination of the foreign service.
