Approval of the BSNL Board is hereby conveyed for filling up of \_\_\_\_\_ Direct recruitment quota vacancies in TTA cadre from the open market as per provisions laid in the Recruitment Rules of TTA-2001 issued under this office letter Nos. 250-41/2001-Pers-III dated 27.7.2001 and amendments issued under letter Nos. 250-41/2001-Pers-III dated 5.11.2001 and 250-17/2008-Pers-III dated 22.8.2008. The Direct Recruitment shall be conducted as per Syllabus and scheme of examination prescribed vide letter No. 250-18/2008-Pers-III dated 4.9.2008.

2. TTA being SSA cadre, the SSA wise distribution of vacancies shall be done by the respective CGMs of the Recruiting circle. While making SSA wise distribution, the demands of non-recruiting units like Project, Maintenance Regions etc. may also be considered by recruiting circles. Recruitment Year shall be treated as 2012.

3. Normal rules on reservation for SC/ST/OBC/PH/Ex-Servicemen shall be applicable. 3% reservation for Physically handicapped persons shall be as per provisions laid in DoT letter Nos. 1-8/2001-AD (SNG) dated 18.10.2001 and 21.4.2003. Instructions issued with regard to reservation for Ex-Servicemen, minimum qualifying standards vide letter Nos. 250-23/2008-Pers-III dated 29.10.2008 and 1.12.2008 shall also be applicable for the ensuing Direct Recruitment.

4. Further instructions regarding maintenance of waiting list shall be issued separately.
