Subject: Promotion of AOs/Sr.AOs to the grade of STS on ad-hoc basis to fill up the vacancies in ST category - reg.

Competent Authority has approved the proposal to fill up the vacancies in the grade of STS in respect of executives of Telecom Finance belonging to ST category by giving promotion on ad-hoc basis to the eligible AOs/Sr AOs as per guidelines contained in BSNL MS Recruitment Rules. A list of AOs/Sr.AOs belonging to ST category, posted in various Circles, who are eligible to be considered by the CPC is given in 'Annexure - 'A'.

2. As the CPC is to be conducted in a time bound manner, concerned Circle IFAs are requested to kindly arrange to send the ACRs/APARs for the year 2011-12 and any other ACRs/APARs for the period from 1.4.2007 to 31.3.2010 lying in their office, in respect of the executives whose names are included in the enclosed list, which was not sent earlier to CS to Director (Finance), CO BSNL.

3. There may be cases of some AOs/Sr. AOs, whose circle of posting shown in the list may not be correct. In such cases, ACRs/APARs ibid, in respect of those executives, who are working in your circle, but their present circle of posting has been shown otherwise in the above mentioned list, may also be sent directly to AGM (SEA), BSNL Corporate office.

4. The following points may be taken care of:

a) In case, any executive against whose name the word "ST" has been inadvertently indicated and is required to be modified, the factual position may be verified from the service records of the executive and confirmed

b) It may be checked and verified from the records, whether the name of the executives, who have already been promoted to the higher grade / who have retired / voluntarily retired / expired / whose promotion has been withheld at the circle level / not permanently absorbed in BSNL / not in service or any other reasons are included in this eligibility list. In such cases, their names may be brought to the notice of this office.


c) Name of any other executive belonging ST category in Telecom Finance, who is eligible for promotion to the grade of STS as per BSNL MS RR as on 1.1.2013 but not included in the above list may also be checked up and intimated to this office along with full particulars.

d) In case, APAR gradings during the period from 1.4.2007 to 31.3.2012 in respect of the executives included in the list are found below the prescribed bench mark as per BSNLMS Recruitment Rules for promotion to the grade of STS in Telecom Finance, concerned circles are requested to ensure that DOP&T guidelines contained in letter No 21011/1/2010-Estt A dated 13th April, 2010 on the subject, has been adhered to in such cases.

Corrections / modifications, if any, to be made in the list, along with missing particulars in the enclosed list may be brought to the notice of this office latest by 15.2.2013.
