- 2. The promotion of the officers is further subject to the conditions that no disciplinary / vigilance case is pending against the officers. If the officers are not working in the respective circle shown against them, the orders should not be implemented, but the officers relieved immediately with direction to report to the circle of posting shown against him and the matter should be reported to CO BSNL HQ,
- 4. On promotion, the pay will be fixed as contemplated in BSNL MS RR, communicated vide no 400-106/2007-Pers I dated 14.7.2009. In respect of Sr. AOs now promoted to STS on regular basis, their pay will be fixed will be fixed in accordance with the instructions contained in the order no. 400-61/2004-Pers I dated 18.1.2007 read with O M no. 1-50/2008-PAT (BSNL) dated 5.3.2009.
