ORDER

Subject: Regularisation of STS Ad-hoc of Telecom Finance / Promotion to the grade of CAO - regarding.

- 2. The promotion of the officers is further subject to the conditions that no disciplinary / vigilance case is pending against the officers. Before implementation of these order(s), the Circle(s) must ensure that Presidential orders for absorption of these officers in BSNL have been issued and officers to be promoted are working in the grade of STS on ad-hoc basis in the circle. If the officers are not working in the respective circle shown against them, the orders should not be implemented, but the officers relieved immediately with direction to report to the circle of posting shown against him and the matter should be reported to CO BSNL HQ,
- 4. On promotion, the pay will be fixed as contemplated in BSNL MS RR, communicated vide no 400-106/2007-Pers I dated 14.7.2009.
