

- 3. The promotion of the officers is further subject to the conditions that no disciplinary / vigilance case is pending against the officers. In case any disciplinary / vigilance case of the type referred to in D.O. P&T OM No. 22011/4/91-Estt. (A) dated 14.09.1992 is pending against the officer or some punishment like stoppage of increment etc. is current, he/she should not be promoted and the matter should be reported to SEA and Vigilance Branch of Corporate Office, BSNL immediately.
- 4. Before implementation of these order(s), the Circle(s) must ensure that Presidential orders for absorption of these officers in BSNL have been issued and officers to be promoted are working in the grade of STS on regular basis in the circle. If the officers are not working in the circle shown against col. 'Present Circle', the earlier orders of transfer should be implemented first, with direction to report to the concerned circle of posting shown against him and the matter should be reported to CO BSNL HQ.
- 5. <u>Any request for declination of promotion will not be entertained by Administration</u> due to administrative exigencies.
- 6. On promotion, the pay will be fixed as contemplated in BSNL MS RR, communicated vide no 400-106/2007-Pers I dated 14.7.2009.
- 7. The officer in case is officiating in the higher grade locally, the arrangement shall stand terminated before implementation of this order.

- 8. The Circles must ensure posting of suitable executives in the SSAs concerned, wherever specific mentioned is not there in CO BSNL order and intimate the name of SSA and branch in which they are posted for records and updating the date. In respect of circles, where executives are posted in excess of available vacant posts in the grade of JAG, necessary post diversion orders will be issued separately from CO BSNL. However circles must ensure posting of officers at appropriate location, so as to utilize their services effectively in the promoted post.
- The executive(s) is/are required to join their assignment on promotion within a time period of 30 days from the date of issue of the order to the concerned circle/station of posting.
- The Executives would not have any claim for their seniority/regular service in DGMs grade of Telecom Finance based on this ad-hoc promotion. Their seniority will continue to be determined with reference to their basic seniority in the substantive grade of CAOs/AGMs of Telecom Finance Service (STS level).
- 11. The date on which the above order are given effect to, may be intimated and necessary charge report sent to all concerned including Dy Manager (SEA), CO BSNL.
- 12. Hindi version will follow.
