Pursuant to BSNL CO's office letter No. 30-1/2009-DE(1) dated 08.07.09, even number dated 10.07.09, No.63-9/2010-DE dated 23.03.2010 and No.30-1/2009-DE dated 09.04.2010, the competent authority is pleased to promote following 64 JTO(Civil) to the grade of SDE(Civil) on the basis of Limited Departmental Competitive Examination (33 % quota) in the Pre- revised IDA pay scale of Rs.11875-300-17275 from the date they assume charge of the higher post. 3. The specific posting orders shall be issued by the Principal Chief Engineer(Civil)/Chief Engineer(Civil) of allotted zone.


4. The Executive shall not be relieved from his present post until and unless specific posting orders are issued.

5. The leave, if any requested by the Executive, who has been posted on promotion to different Civil Zone, should not be allowed. If any officer desires leave, he/she can apply for leave to new Head of Civil Zone under whom he/she has been posted only after joining the new post and new head of Civil Zone will sanction leave, if it is considered justified in normal course.

6. The date on which the above order is given effect to may be intimated to this office and a consolidated report of the Executives who have been relieved/ have joined their new postings may also be sent immediately. Charge reports need not be endorsed to this office.
