With reference to the above subject, the policy has been made operational from 01.06.2023 in association with The Oriental Insurance Company for a period of 1 year i.e till 31.05.2024. TPA for the policy is "MD India Health Insurance Private Limited".

E-cards of the employees and their dependents who have opted for the policy can be downloaded from dedicated "**MDI BSNL Mediclaim Insurance**" app available on *Google Play Store* and *App Store*. Besides e-card, other information such as Policy/claim/hospitals details etc. are also available on the app.

3. The **User ID for login is Employee Pernr No.** (without prefixed zeros 0/00/000/0000, wherever applicable) and the **password is Date of Birth in DDMMYYYY** format. For example Userid for employee with Pernr no.0080XXXX will be 80XXXX and Password to be entered for DOB 1st January 1990 shall be 01011990.

4. For smooth functioning of the policy, followings are enclosed herewith :

- i. Policy document Base policy (214600/48/2024/706) and Top up policy (214600/48/2024/707) along with their respective annexures received from the Insurer is enclosed at **Annexure-I**.
