**Subject: Unjustified and illogical posting orders of DEs on promotion in NTR Circle-Reg.**

**Reference: No.412 16/2014-Pers.I Dated August 20, 2014**

**Respected Sir,**

We are constrained to bring to your kind notice that in the recent promotion order of DEs as referred above, the NTR Circle management after 23 days has issued posting orders on promotion vide letter number 1-2/2012-Admn/KW/69 dated 11.09.2014 (**Copy Enclosed**) for 18 DEs wherein, 17 DEs have been have been posted to distant stations / circles in NTR region whereas on the stations / circles where these executives are working sufficient vacancies are available to accommodated them as DE and after transferring these executives from their stations DEs from other stations have been posted. It has caused major dislocation to the DEs and financial loss to BSNL on TA / TPN etc. This is an unjustified and illogical act of the NTR Circle management.


It seems that the NTR Circle management is interested in harassing the DEs by transferring them to distant circles / stations who got their 2<sup>nd</sup> promotion after 30 years of service. The BSNL Corporate Office in the promotional orders has tried to accommodate majority of the DEs in the same circles wherever the vacancies were available on priority basis. But the NTR circle, out of the 18 DEs, has transferred 17 DEs to distant circles / stations ignoring the BSNL Corporate Office guidelines and financial constraints of BSNL. It reflects the dictatorial and indifferent attitude of the NTR Circle management towards executives.

Further, NTR management is trying to retain or take more DEs to NTR circle to victimize and harass them by transferring them to distant circles / stations on unjustified and illogical grounds.

In view of the above, it is requested to kindly intervene in the matter so that all the DEs posted in NTR circle are transferred to their parent territorial circles and further no DEs are posted in NTR circle to save them from victimization.
