Subject: Non-Implementation of policy on Immunity from Transfers- the cases of Shri M. Ganapati Reddy, AO (Branch Secretary of STP&STR, Andhra Pradesh), Shri Mohandoss, AO (Branch Secretary of Karaikudi SSA, Tamilnadu) and Shri C.Arumugam DGM (Branch Secretary of Vellore SSA, Tamilnadu), Regarding.

Respected Madam,

We would like to bring to your kind notice regarding the above issue on which necessary clarification was already issued by the Corporate Management. Accordingly the office bearers who are to be considered for immunity from transfers at least for one term of their office in Association at all levels have to be granted this facility so that they may discharge their organizational duty without any hindrance. The purpose for which this facility was granted to the Associations is not understood by the some officers' right from top to bottom. They know very well the purpose. Whether it may be promotion or of any other reason, the eligible office bearers have to protect from transfer just for discharging the duty assigned by their respective organization.

While this order is taken in good spirit and invariably followed at all levels in Engineering wing, the top level officers of Accounts wing are refusing even to consider the order issued by the Corporate Management. We cannot compromise on this issue and some officers in the Accounts wing in the Corporate Office cannot snatch away the rights and privileges granted to the Associations/ Unions.

If they negatively decide and transfer our members who are the office bearers it will create a wedge among our members and leads to misunderstanding. Particularly in our Association in all the Circles right from top to bottom many Accounts Officers are holding key posts in our Association who are to be ensured this immunity facility as availed by Engineering Comrades. In case they are disturbed at all levels we cannot run our organization successfully.

Hence we request you good office that this case may be settled once for all and the transfer orders already issued may be cancelled. **The cases of Shri M. Ganapati Reddy, AO (Branch Secretary of STP&STR, Andhra Pradesh), Shri Mohandoss, AO (Branch Secretary of Karaikudi SSA, Tamilnadu) and Shri C.Arumugam DGM (Branch Secretary of Vellore SSA, Tamilnadu)** who have been transferred may be taken as an example and be resolved in the true spirit of the immunity granted to the office bearers of the Associations/Union.
