Sub: Non finalization of Group 'A' RRs in BSNL-Reg.

Sir,

We are constraint to bring to your kind notice that the members of this association are seriously frustrated and agitated against non finalization of Group 'A' RRs .

About nine years are completing after formation of BSNL w.e.f. 01.10.2000, but no Group 'B' or Adhoc Group 'A' level executives in BSNL has been promoted on regular basis on the pretext of pending Group 'A' RRs. BSNL executives after their absorption in BSNL are simply retiring as Gr. 'B' or adhoc Group 'A' level executives, Whereas, UPSC has conducted a number of DPCs after 01.10.2000 for promotion from STS to JAG, JAG to SAG and SAG to HAG of Indian Telecom Service Group 'A' of department of Telecommunications. These promotions of deputationists have taken place even against the posts created by BSNL of which is the Public Sector Undertaking. After these promotions these officers are continued to serve in BSNL.

It is reliably learnt that BSNL Board has approved the Group 'A' RRs, but the same is not being notified. The absorbed Group 'B' and Group 'A' level executives in BSNL, if they could have continued in DOT by not taking absorption in BSNL, during these 9 years period w.e.f. 01.10.2000 so many of them could have been promoted as regular Group 'A' officers by UPSC. It is a gross injustice to the absorbed BSNL executives. This has caused serious discontent and frustration in the minds of absorbed executives.

It is also understood that BSNL Management Committee has decided to start the process of regularisation of Adhoc Group 'A' level executives, but the same is being delayed on the pretext of holding of DPCs from Adhoc to regular posts in the same cadre which is not at all justified, since the attendant conditions, eligibility criteria and DPC level is the same

for Adhoc or regular. Hence it is a technical transition from Adhoc to regular on the same post/grade.

In view of the above, we shall request you to kindly intervene in the matter so that Group 'A' RRs approved by BSNL Board are immediately notified and the regularization of Adhoc Group 'A' executives is completed from the date of adhoc DPC.
