3. The officers now promoted, in case are officiating on local arrangement basis in the grade of JAG by an order of the Circle, should be reverted to their substantive grade and be promoted afresh in compliance with this order, after giving a break of one day.
4. The pay of the officers will be fixed under FR 22(I) (a) (i) with reference to their pay in the grade of STS.
5. If the officers are on leave/training, they shall be promoted with effect from the date of joining on return from such leave/training.
