A provisional Combined Seniority/Gradation list in respect of Sr. Accounts Officer(s)/Accounts Officer(s) working in BSNL , as on 01.05.2008 is forwarded herewith (As Annexure)

1. A copy of the Seniority list may be given to all officers concerned and acknowledgement be obtained. Representation regarding discrepancy of seniority, if any, noticed in the seniority list may be forwarded to this office in <u>ONE BATCH</u> with requisite authenticated supporting documents and also with your comments so as to reach this office on or before 01.08.2008. Representations received directly and /or received after 01.08.2008 or representations received without supporting documents will not be entertained at this end.

- 2. The points that need your attention are :
 - i) It may be noted that the cadre of Sr. Accounts Officer is not a substantive grade as per the provisions of Post Based promotions under Time Bound Executive Promotion Policy notified by CO BSNL Vide OM. No. 400-61/2004-Pers.I dated 18.01.07 and hence the Combined seniority list of Sr. AO/AO is being issued.
 - ii) The particulars furnished in all the column(s) may be verified and necessary correction, if any, may be intimated.
 - iii) In case, the official against whose names the word 'OC' or 'SC' or 'ST' have been wrongly indicated or required to be added, the factual position may be verified from the service records of the official and confirmed.
 - iv) The particulars in Column 7 & 8 , the date of actual promotion of the official as AO/Sr. AO may be informed for incorporating in the seniority list.

- v) It may be checked whether names of all officers who had declined promotion to the grade of AO/Sr. AO or whose orders could not be executed due to administrative reasons, if any, have been shown at the appropriate place in the seniority list .(They will loose seniority vis-à-vis their juniors promoted to the higher grade earlier).
- vi) It may be checked whether name of the officer who have already been promoted to the higher grade/who have retired/voluntarily retired /expired /whose promotions has been withheld at the circle level/ absorbed elsewhere permanently /not in service/not promoted to the higher grade /not absorbed in BSNL or any other reason are included in this seniority list. In such cases, a separate list may be got prepared and sent to this office.
- vii) Any name to be added or to be deleted or names to be corrected may also be checked up and intimated along with reasons.
- viii) Missing particulars in the columns Viz. date of birth, date of entry, and date of promotion may please be supplied to this office.
- ix) There may be cases of some officers whose circle of posting shown in the list may not be correct. In such cases, in respect of those officers who are working in your circle, but their present circles of posting has been shown otherwise, particulars shown in the seniority list may be verified and correction, if any, may be intimated to this office, along with supporting documents.
- 3. Corrections/changes /insertions to be made in the list along with missing particulars in the seniority list etc, may be sent to this office by 01.08.2008 in <u>ONE LOT.</u>
