ORDER

Subject: Promotion and postings in the grade of Senior Time scale of Accounts and Finance Service on purely temporary and ad-hoc basis - regarding.

The following Senior Accounts Officers of Accounts and Finance Service, who are permanently absorbed in BSNL, are hereby ordered to officiate on ad-hoc basis in the grade of Senior Time Scale of Accounts and Finance Service, in IDA pay scale of Rs. 29,100 - 54,500 (revised) / Rs. 14,500-350-18,700/- (pre-revised), with effect from 27.3.09 or from the date, their juniors ordered to officiate in the grade of STS on ad-hoc basis, vide this office promotion order of even no dated 27.03.2009 in the circle, whichever is later, until further orders. 3. The promotion of the officers is further subject to the conditions that no disciplinary / vigilance case is pending against the officer. In case any disciplinary / vigilance case of the type referred to in D.O. P&T OM No. 22011/4/91-Estt. (A) dated 14.09.1992 is pending against the officer or some punishment like stoppage of increment etc. is current, he should not be promoted and the matter should be reported to SEA and Vigilance Branch of Corporate Office immediately.

4. Before implementation of these order(s), the Circle(s) must ensure that Presidential orders for absorption of these officers in BSNL have been issued and officers to be promoted are working in the grade of Sr. AO on regular basis. In case, the Presidential order is not issued or the officers are not working as Sr. AO on regular basis, the order should not be implemented and it should be immediately brought to the notice of SEA Section of Corporate Office, BSNL. <u>Any request for declination of promotion will not be entertained by Administration due to administrative exigencies.</u>

5. On promotion to the grade of STS on ad-hoc basis, the pay of the officers will be fixed as per the promotion policy issued vide O M no. 400-61/2004-Pers I dated 18.1.2007 and PAT branch CO BSNL letter no. 1-50/2008-PAT(BSNL) dated 5.3.2009.

6. All regular Group 'A' officers of IP&T AFS Group 'A', who are senior to these officers, but not absorbed in BSNL till date, due to administrative reasons will rank enblock senior to these officers on their absorption in BSNL.

7. The above ad-hoc STS promotion is further subject to the condition that the above mentioned officers may be reverted at any time due to administrative exigencies.

8. The above ad-hoc STS promotion will neither bestow on the officers any claim for regular appointment to the higher grade nor will the services rendered by them in the grade of STS count for the purpose of seniority in the grade or for promotion to the next higher grade.

9. The officer in case is officiating in the higher grade locally, the arrangement shall stand terminated before implementation of this order.

10. TA/TP may be regulated as per the guidelines issued by CO BSNL OM No. 19-27/2002-L&A (PT.) Dated 15.04.2004.

The leave, if any requested by the officer, under transfer, should not be granted under any circumstances by the Circle(s) where they are working presently without prior permission of the CO BSNL. The officer can apply for leave to the Competent Authority at the new place of posting, who will sanction the same, if it is justified in the normal course.

12. This issues with the approval of the Competent Authority.

13. All the IFAs may please check up the up-to-date position regarding the vacancies in the grade of STS in their circles after implementation of the above order and intimate the same to SEA Section, CO BSNL, New Delhi.
