Sub:- Diversion of posts of JTO from DR Quota to 35% departmental Quota- Latest decision of Management Committee of BSNL Board in meeting on 4-11-2008 to re-divert 3500 posts back to DR quota- its consequence on the presently officiating JTOs- reg

Sir,

As you know that the orders of the Hon. High Court of Haryana and Punjab dated 30-5-2008 in CWP No.5608/2007, the management committee of BSNL Board has decided to stop diversion of DR quota posts of JTOs to 35% departmental quota. The committee also decided that the 3500 JTO posts of DR quota already diverted to 35% departmental quota will stand re-diverted to DR quota with immediate effect. The management committee further took a decision to create 3500 supernumerary posts as a special measure to adjust those officials who have already been promoted and posted against the above said 3500 posts all over India. It is stated that, these supernumerary posts will be kept as a separate group and will not be part of the regular sanctioned strength of JTOs, and will stand abolished as and when the incumbents of these posts vacate the same due to retirement, promotion etc.


With the above decision of the management committee, the issue related to the regular posting of 3500 officials already promoted to JTO cadre will be settled permanently. But, still there are a considerably good number of qualified officials who have completed phase-I training and are waiting for regular posting as JTO. Majority of them are now officiating as JTOs and their total number comes to about 2200. The fate of these remaining officials who are equally qualified and eligible for posting as the 3500 already regularized, is not clarified or mentioned in the said decision of management committee of BSNL Board on 4-11-2008.

The issue can be resolved permanently if the required number of supernumerary posts are created in each circle to accommodate these remaining officials also, as being done now in the case of 3500 officials already posted. This genuine demand to create supernumerary posts for the remaining cases also with the same norms applicable to all because different standards cannot be applied to the same group of equally qualified officials.

We would therefore request you to kindly intervene in the matter so that the required number of supernumerary posts in each Circle are created to promote all officiating JTOs on regular basis.
