As per this office letter No.1-33/2008-PAT(BSNL) dated 24.11.2008, the first instalment of arrears of pay i.e. 40% of the aggregate arrears has been paid to unabsorbed employees working on deemed deputation / deputation basis as per Govt Orders on the recommendation of the 6th Central Pay Commission in terms of Ministry of Finance, Department of Expenditure OM No.1/1/2008-IC dated 30.8.2008. Further, the absorbed executive employees were also paid 40% of the arrears of pay on the implementation of the 2nd PRC in terms of this Office Order No.1-50/2008-PAT(BSNL) dated 5.3.2009.

Now, Department of Telecom vide letter no. 1-5(1)2008-PAT dated 28-08-2009 has forwarded a copy of the Ministry of Finance, Department of Expenditure vide OM No.1/12008-IC dated 25.8.2009 for payment of second instalment of arrears i.e. 60% of arrears of pay on account of implementation of 6th CPC recommendations for Central Govt. employees.

 - (ii) For making payment of remaining 60% of the arrears of pay to the Board level and below Board level Executives who were paid 40 % of the arrears as this office order No.1-50/2008-PAT(BSNL) dated 5.3.2009.
- 4. It is, therefore, requested that payment of 60% of the arrears of pay to the un-absorbed officers and absorbed executives as mentioned in para 3(i) and and (ii) above may be paid at the earliest.
