Sub :- Payment of 2nd instalment of pay arrears to BSNL employees.

Sir,

As per this office letter No.1-33/2008-PAT(BSNL) dated 24.11.2008, the first instalment of arrears of pay i.e. 40% of the aggregate arrears has been paid to unabsorbed employees working on deemed deputation / deputation basis as per Govt Orders on the recommendation of the 6th Central Pay Commission in terms of Ministry of Finance, Department of Expenditure OM No.1/1/2008-IC dated 30.8.2008. Further, the absorbed executive employees were also paid 40% of the arrears of pay on the implementation of the 2nd PRC in terms of this Office Order No.1-50/2008-PAT(BSNL) dated 5.3.2009.

2. Now, Department of Telecom vide letter no. 1-5(1)2008-PAT dated 28-08-2009 has forwarded a copy of the Ministry of Finance, Department of Expenditure vide OM No.1/12008-IC dated 25.8.2009 for payment of second instalment of arrears i.e. 60% of arrears of pay on account of implementation of 6th CPC recommendations for Central Govt. employees.

3. Accordingly, this matter has been considered in this office and the approval of the competent authority is, hereby, conveyed as per following:

- (i) For making payment of remaining 60% of arrears of pay to the unabsorbed officers working on deemed deputation/ deputation basis who were paid 40% of the arrears as per this office letter No.1-33/2008-PAT(BSNL) dated 24-11-2008.
- (ii) For making payment of remaining 60% of the arrears of pay to the Board level and below Board level Executives who were paid 40 % of the arrears as this office order No.1-50/2008-PAT(BSNL) dated 5.3.2009.

4. It is, therefore, requested that payment of 60% of the arrears of pay to the un-absorbed officers and absorbed executives as mentioned in para 3(i) and (ii) above may be paid at the earliest.
