Respected Sir,

With reference to above subject and letters we have raised many vital issues related to MSRRs 2023 issued for different streams and on the other matters related to the HR issues including career progression of BSNL Executives. We have been waiting for favourable action and justice to the executives in BSNL from BSNL management for more than last three months. However, it is saddened to mention that no response happened from your end even after the submission of reminder request letter on 9<sup>th</sup> Feb 2023. Now the Forum feels that CMD/BSNL Management is leading unilaterally uncaring the very genuine submissions of the Forum. No way, it is appreciable and this attitude of BSNL Management would be very detrimental to the growth of BSNL. Also, this pace of BSNL Management is just pushing the vision of the Government of India in peril to turn around BSNL by providing 2 back to back revival packages. Forum of Associations has raised many issues related to MS RRs 2023 and is continuously pursuing with concerned officers for desired action as requested by Forum. But till today, no action has been taken on any of the issues and all the letter of Forum are seen unaddressed. Unfortunately, some of the responsible officers from BSNL management are propagating that no Association has any objection or issue with the New MSRRs, which is a still born child, legally. We re-emphasise that there are many issues affecting to the career progression of the Executives in BSNL due to modification in MSRRs 2023, which is not as per DoPT guidelines and also not as per the guidelines of the Hon. Supreme Court of India.

Due to our sincere obligations and regards to the GOI upon the provision of two back to back revival packages for the turnaround of BSNL, we are reluctant to go for an agitation. However it shall not be taken as a clean chit for the handicapped MSRR 2023. Forum emphasizes without any ambiguity that the lamed MSRRs 2023 are not acceptable to BSNL executives until the MSRRs are modified according to the prevailing DOPT and Hon SC guidelines

We have also raised many serious issues through the subsequent forum letters but management hasn't shown any listening and response towards the letters written by the General Secretaries of Associations representing almost all executives in BSNL is a matter of serious concern in general.

With this reminder, we once again request your good self to direct concern officers to look into all grievances raised in different letters since last two months and we are raising now and direct them to look into issues. It will be most appropriate that special discussions are held or the proper reply is given by BSNL for non-consideration of issues raised by us, so that same can be updated to executives in BSNL and ongoing unrest can be arrested before it further bursts and something happens wrong in the BSNL.
