Subject: Filling up the vacant posts of CMD, BSNL, Director (HR), and Director (Finance) of BSNL-reg.

Hon'ble Sir,

We are extremely happy to note that you are sincerely trying for the revival of BSNL and MTNL. Some steps in this connection has been taken by your good office but the important issue remains pending i.e. the vacant posts of CMD BSNL, Director (HR) and Director (Finance) Posts of BSNL. Personally, all these three posts are being looked after by Shri A.N Rai, Director (EB) of BSNL Board. Shri Rai is making his sincere efforts to look after these vacant posts in addition to his own post of Director (EB) but in such a big PSU having 2.44 lakhs employees (Executives & non Executives) and having about 26000 Crore turnover per annum, it is difficult to do justice with these functions and has caused a overload to one Director (EB).

The fact remains that despite the sincere efforts and involvement of Director (EB) against all the vacant posts of BSNL Board, many work remains unattended due to paucity of time and extra work. It is indirectly affecting the viability of BSNL. All these posts of CMD BSNL, Director (HR) and Director (Finance) are equally important and needs independent officers on full time appointment. BSNL is incurring continues losses for the last five years i.e. After FY 2008-09 and has incurred about 32000 Crore losses during this period. The same PSU had earned about 40000 Crore profit after its inception in 1.10.2000 to the year 2008-09. This is the time when BSNL need committed leaders to turn around the company. The CMD, BSNL leader of the company should be a strong one who have good liaison with Govt. and following of BSNL workers.

PSEB has already conducted interviews long before for the posts of CMD BSNL and Director (HR) but till now no appointment has been made by the previous UPA Govt. and now by the NDA Govt. The interview for Director (Finance) has not yet been conducted

whereas the post is lying vacant for the last 9-10 months. For the revival of BSNL full Board of Directors appointment is a must to own the responsibility in real sense. In view of the above, we would therefore request to your kind honor to kindly intervene in the matter so that the vacant posts of BSNL Board are immediately filled up by the committed leaders. We assure our fullest support in your endeavor to turn around the BSNL.
