In continuation of the request letter referenced above, we earnestly submit the following for your kind consideration and respectfully request your prompt and favorable directives to the concerned authorities for the early issuance of promotions from AO to CAO cadre.

The referenced letter is being submitted for your kind consideration following the interim order issued by the Hon'ble High Court of Punjab & Haryana at Chandigarh on 20.01.2025, directing the issuance of long-pending AO to CAO promotions. Despite these clear directions from the Hon'ble High Court, BSNL has not yet released the AO to CAO promotions.

Meanwhile, some officials approached the Hon'ble Supreme Court of India, which, through its order in SLP(C) Diary No. 11782/2025 dated 24.03.2025, directed BSNL "not to disturb the present position of the petitioners." The case is scheduled to be heard further along with Civil Appeal No. 629/2022 (Jarnail Singh & Ors), which is already pending before the Hon'ble Supreme Court.

Sir, as there are no legal hurdles in the directions of the Hon'ble Supreme Court and High Courts, BSNL can proceed with issuing CAO promotions. Currently, only 35 CAOs are working against 756 vacant posts; therefore, the early release of promotion orders is crucial and highly essential.
