## Subject: Utilization of 50% MT Internal Quota Posts in Accounts Wing to the Seniority Quota Posts of CAOs for giving promotions on ad-hoc basis in view of acute stagnation in the Cadre of Accounts Officers – our submissions regarding

### Reference: Letter No. AIBSNLEA/CHQ/CMD/2018 DATED 14.06.2018

#### **Respected Sir**,

On the subject cited above, we would like to draw your kind attention towards our letter cited under reference above, wherein we have requested to kindly allow ad-hoc promotions to the post of CAOs against the 50% MT Internal quota posts in Accounts wing till the matter is considered and disposed of by the BSNL Board. Copy of the letters are attached herewith for ready reference.

As on date, about 40 CAOs are working only in BSNL on Regular/Adhoc basis out of the total diversion of 50% MT Internal Quota Posts in Accounts Wing to the Seniority Quota Posts of CAOs 1347 sanctioned posts. More than 620 CAO posts in SCF quota are lying vacant as well as 673 MT quota posts are also vacant and unutilized since long. Nearly 1400 eligible Accounts Officers are waiting for their promotions to the post of CAO since past 13-14 years.

In Telecom Wing, the 50% diversion of MT quota posts to the SCF quota has already been taken place on regular basis since long.

Under these circumstances, we would like to request your good self to kindly consider the utilization of 50% MT Internal Quota Posts (336 in numbers) in Accounts Wing to the Seniority Quota Posts of CAOs for giving ad-hoc promotion in view of acute shortage of Chief Accounts Officers and stagnation in the cadre of Accounts Officers as a onetime measure by getting approval from the Management Committee of the Board as per BSNL MSRRs provisions.
