Sub: Request for cancellation of mass transfer orders issued to Accounts Personnel on CAO Promotion – Reg.

Ref: BSNL CO, ND Lr.NO.2-4/2018 SEA-BSNL dated 20.11.2018

Respected Sir,

While extending our sincere gratitude and thanks for issuance of AO to CAO promotion orders for 468 Accounts Personnel, we would like to draw your kind attention towards the transfer orders issued to 71 Accounts Personnel in the above cited CAO Promotions orders issued by the BSNL Corporate Office on 20.11.2018

In this regard we would like to submit that

1. While issuing bulk promotion orders in the cadre of JAO to AO, JTO (T) to SDE (T), SDE(T) to DE, and also in other disciplines during the month of June 2018 and July 2018, all the promoted officers were accommodated in their Home Circles even though vacancies were not available. But in the case of CAOs, sufficient vacancies are available in all the Circle but they have been transferred from their Home Circle.
2. Almost in all the Circles JAOs and AOs were promoted and the question of shortage in those Circles does not arise.
3. All the newly promoted CAOs have completed 56 years and they all served in other Circles two tenure, one in the cadre of JAO and second in the cadre of AO have further been transferred .
4. Even the Accounts officers completed 59 years age and at the verge of retirement have also been transferred from their home Circle.
5. Above all, now BSNL is in huge financial crunch, no funds are allotted under TA, Medical and even for the payment of Electricity bills, Diesel and other maintenance expenditure and in addition to that, due to deplete of Revenue, BSNL is struggling for allotment of funds for monthly Salary Expenditure and trying for Loan from


various Banks for meeting OPEX through Letter of Comfort to be authorized by DoT. As such, BSNL is observing various austerity measures. At this juncture, spending a huge Expenditure towards Transfer TA, Furnishing Allowance etc., to the tune of more than Rs.2 Crores by transferring 71 Accounts Officers on Promotion is not desirable.


6. In future if any transfer is essential in the interest of BSNL may be issued on need basis.

In view of the foregoing, we would therefore request your good self to kindly intervene in this matter and cause to issue necessary instructions to the Officers concerned to cancel the transfer orders issued to the Accounts Officers on promotion in the interest of BSNL.
