Subject: Filling-up of the vacant Four Executive Director (ED) posts in BSNL – Our concern regarding.

Respected Sir,

We would like to draw your kind attention towards filling-up of the vacant four Executive Director posts in BSNL. You are aware that all the four Executive Director Posts in BSNL are lying vacant for the last two-three years. These Executive Director posts, to our knowledge were created in BSNL to have an effective supervision on the circles on Zonal basis but later on, these posts were kept in BSNL Corporate Office in the name of ED (NB), ED (CA), ED (CN) and ED (Finance).

These Executive Directors were contributing a lot in assisting the Board of Directors and CMD BSNL in their day to day work. They were controlling the Non-recruiting Circles, Telecom Factories, Civil, Electrical and Architectural Wings. They were also contributing with their valuable suggestions to the Management Committee of BSNL Board. In absence of appointment of Executive Directors all the above functions are being looked after by the Internal Board of Directors in addition to their normal functions. Moreover the present Board of Directors are already having double charge of HR & Finance, EB & CFA and shortly, Director (CM) is going to be vacated on 30.06.2018.

The Executive Director's establishments are now being allotted to HAG and SAG level officers and some HAG / SAG level officers are demanding Executive Director's facilities without owning the responsibility of the ED Post. Further, these Executive Director Posts were earmarked in BSNL as en-cadre Post for the BSNL absorbed Group "A" officers of various disciplines. Thus absorbed Group "A" Officers were inspiring their promotions to the rank of Executive Director which is missing today.

We would, therefore, request you to kindly take necessary steps to fill-up of these vacant Executive Director Posts in the interest of BSNL.
