Subject: Amendments in the BSNL MRS facility – Our concern regarding reduction in the eligibility criterion for the Out Door medical treatments.

Respected Sir,

We are constrained to bring to your kind notice that BSNL Management is moving ahead for the curtailment in the eligibility criterion of the Out Door Medical bill reimbursement policy at the cost of the life of its employees and pensioners. To our dismay, BSNL Management is planning to reduce the number of days from 23 to 15, on the basis of which the ceiling limit is decided,

Earlier, the ceiling limit was 25 days salary in a Financial Year for the reimbursement of Out Door Medical Bills which was reduced to 23 days and now being reduced to 15 days in the name of austerity measures.

It is worthwhile to mention that BSNL MRS for the BSNL employees and its pensioners was approved and decided by the BSNL Board just after its formation and looking into the provisions of BSNL MRS many DoT employees opted for BSNL. Now, with the approval of the BSNL Management Committee and through administrative orders the amendments are being made in the settled BSNL MRS. It has caused serious resentments and frustration among the BSNL employees as well as pensioners.

To impose austerity measures, there are many areas in BSNL where the curtailment in the wasteful expenditure can be made to save BSNL money for example curtailment in regular foreign trips, heavy expenses on the Study / Management Courses at the cost of BSNL, purchase of obsolete technology equipment, wasteful expenditure in the Sales and Marketing meetings, unwanted TA / DA & Hotel expenses, unwanted legal expenses and electricity bills etc. Further, in the cases, where the complaints of misuse of BSNL MRS are received, vigilance inquiry may be conducted and the action may be taken against the erring officials.

We would, therefore, request you to kindly intervene in the matter and direct the concerned officers to restrain from such move of curtailment in BSNL MRS at the cost of the life of BSNL employees and BSNL pensioners.
