Subject: The Problems faced by the Executives posted in Hard/ Soft Tenure Stations due to Covid-19 Nationwide Lockdown - Reg.

Respected Sir,

We would like to draw your kind attention on the above cited subject. In this regard, we would like to bring to your kind notice about the problems being faced by the Executives posted in Hard/ Soft, Tenure Stations during Covid-19 Nationwide Lockdown.

During the Nationwide Łockdown Period due to Covid-19, the BSNL Executives working in the Stations other than their Home town providing the Essential Telecom Services very smoothly to the Warriors of Covid-19 as well as the General Public. But, they have been forced to complete the assigned/ targeted work within the stipulated time during Lockdown Period and even they are unable to go to their Home town/ Native place to look after their family by availing the Earned Leave due to them, since they are away from their home town to maintain the Essential Telecom Services during this Pandemic Situation on war footing basis at their posting Stations. They have maintained the Telecom Network in an excellent manner everywhere.

Sir, now if they want to visit their Home town to look after their family, they will be forced to remain Quarantine for 14 days at the Home town and again 14 days Quarantine after returning back at the work place, and so they have to avail 28 days forced Earned Leave.

We, on behalf of AIBSNLEA wish to submit that the Executives posted on the Hard/Soft Tenure Stations away from their Home Town may be allowed to carry forward the Earned Leave earned during 1st January 2020 and 1st July 2020, as a special case, which is likely to be lapsed due to non-availment,

In view of the foregoing, we would request your good self to kindly consider the above suggestions of AIBSNLEA, as a special case on Humanitarian Grounds and cause to issue necessary instructions to the officers concerned in this regard.
