**Subject: Non-issuance of Tenure Transfer Orders in respect of Accounts Personnel- Reg.

Respected Sir,

We are constrained to bring to your kind notice that many Executives from Accounts wing are working in various Tenure Stations viz: Assam, NE-I, NE-II etc., and most of the Executives have already been **completed their Tenure Period in March First Week of 2020** in different Circles, but till date no transfer order has been issued by the Pers. Section of BSNL Corporate Office. They are eagerly waiting to join with their family at their Home Circle after completion of the Tenure.

On the other side, the same Pers. Section (Corporate Office) has already issued transfer orders for other wings for those Executives who are going to complete their Tenure Period in the Month of March, April & May, 2020 (Copy enclosed for ready reference) but Accounts Wing Executives are still waiting for their genuine transfers.

Sir, such a discriminatory and biased attitude of the Pers. Branch, Corporate Office has created heart burn, humiliation and demoralisation among the Accounts Personnel working in the Tenure Circles and it will not create healthy atmosphere among all the Executives working in BSNL. As such these Executives, who have obeyed the orders of Corporate Office and served in Tenure Stations and completed the Tenure Period, may be transferred immediately to their Home Circles as per the Transfer Policy.

In view of the foregoing, we would request your good self to kindly intervene in the matter and cause to issue necessary instructions to the officers concern to release the transfer orders for all the Executives, who have already completed/ going to complete the tenure period in the tenure stations, to boost the Morale of the Executives in BSNL.
