Kindly refer to this office instructions issued w.r.t. above referred letter at Sr. No. 1, vide which this office had earlier called the vigilance clearance from O/o CVO, BSNL CO, New Delhi in respect of all AGM/DEs (adhoc) & SDEs whose names appear in the seniority list no. 5, 6 and 7. In this regard, AGM (VA), O/o CVO, BSNL CO, New Delhi intimated that the vigilance clearance could not be processed in the absence of data viz. Staff No /HRMS No, Date of Birth, Present circle etc. Accordingly, this office was unable to furnish the list to vigilance cell as the details such as Present working circle/Date of Birth/HRMS no were missing in most of the cases, due to non receipt of complete screening committee report from all the Telecom Circles.

Further, after verification the circle may forward the details in the attached annexure [Sl. No. 1 to 14] to this office latest by 31/05/2017 positively. Besides, the circle may also issue instructions to all the executives { SDEs / DE(T) / DGM(T) } to update their staff no. through ESS as per the letter issued by this office [referred at sr. no. 2].
