Ref.: This office letters of even number dated 08.04.2022 & 11.04.2022.

Kindly refer to letter's under reference regarding implementation of the "Group Health Insurance Policy for BSNL Employees" w.e.f. 01st May, 2022 in association with M/s Oriental Insurance Co Ltd. The policy received a very good response from BSNL employees. However, still some employees were unable to opt for the policy due to various reasons and they have requested for another chance for opting the said policy.

In this regard, Competent Authority has decided to open 2nd window for submitting option for the subject policy with following Terms & Conditions :

- a. The willing BSNL Employees are required to exercise their options to join the scheme online through ERP/ESS portal. The POP UP window in ERP/ESS Portal shall be opened for 8 days. The window shall be opened for submitting option from 11.05.2022 to 18.05.2022. <u>No withdrawal option shall be available i.e. once opted for the policy, it cannot be withdrawn in any case.</u>
- b. The policy will be effective from 01.06.22 to 30.04.23 (11 months) on pro-rata basis.
- c. The premium to be paid shall be on pro-rata basis i.e. for 11 months.
- d. Only those existing employees who have not opted earlier or those who have withdrawn the option due to any reason are eligible to apply.
- e. In case of those employees who have already opted for the policy in April, 2022, no withdrawal or modification of any kind is allowed.
- f. The premium shall be deducted from the salary of the concerned BSNL employee from the month of May, 2022.
- g. All other Terms & Conditions and/ or eligibility/applicability of policy/ MoU notified earlier remains same.
