

I am directed to refer to Hon'ble CAT Principal Bench order dt 3/11/2014 in OA No.3883/2014,MA No.3364/2014 and MA No.2265/2014 vide which it has been ordered "we dispose of this OA at the admission stage itself by directing the respondents to consider the cases of applicants in the light of aforesaid orders (in OA No.1282/2010) and after consideration,if they found that applicants are covered by the aforesaid decisions ,they shall be extended the same benefits & in any case,they shall pass appropriate orders within a period of two months from the date of receipt of copy of the orders".

The matter has been examined and it has been decided to implement the order of Hon'ble CAT Principal Bench ,New Delhi to the members of AIBSNLEA (applicants in this case, list attached) and to the other 244 officials who are applicants (list attached) in this case. The implementation will be subject to outcome of the WP's pending before Hon'ble High Court of Kerala.
