Kindly find enclosed herewith the representation from Sh. P.V. Waghmare, SDE CNTX W, HR No. 199308154 had completed his hard tenure at J & K and joined CNTX W in June 2022. Now in the recent SDE to AGM Promotions, the official is transferred to KTK circle which is injustice to official and has been forced to face hardship again.

As per transfer policy Section B clause 11 (e) which states that "In the career span of all executives, normally one hard tenure such as North East, Assam, J&K, A&N Islands and one term in other tenure circles/SSAs. If any, would be required. After completion of tenure, the executives shall be accommodated at the Circle of their choice as far as possible and not generally disturbed for the next three years."

The official was transferred from MH to J&K but while coming back, he was posed to CNTX Circle and not MH circle, through choice stations are normally given, hence he has to face hardship. Now again before completion of three years he is again transferred to KTK circle on promotion.
