

Subject: Redistribution of Hindi cadre Posts of Kanistha Rajbhasha Adikari and JHT & SHT.

Sir,

BSNL Board had approved restructured manpower requirement in BSNL after implementation of VRS and the approved manpower requirement was circulated vide Letter No. 4-02/2021- Restg. dated 23.11.2021. As per the restructured manpower requirement, the post of JTO (OL) (now designated as Kanistha Rajbhasha Adhikari) is included in the approved manpower of Telecom Stream. Subsequently, the total number of Kanistha Rajbhasha Adhikari in BSNL has been determined to be 51 and the same has also been incorporated in the Recruitment Rules of the post. Further, in the post VRS restructured manpower provision, the approved combined strength of Jr. Hindi Translator (JHT) and Sr. Hindi Translator (SHT) has been fixed as 146.


With the objective of optimum utilization of Rajbhasha Officers/Officials, the circle-wise distribution of 51 posts Kanishth Rajbhasha Adhikari and redistribution of 146 posts of JHT & SHT has been decided as indicated in Annexure-1 enclosed.


