

Please refer to this office letter no.3-8/2010/Estt-IV/Pt dated 04.09.2015 on the subject mentioned above vide which the list of officiating JTOs was enclosed for fixation of their pay under FRR 22 1 (a)(i) in compliance to CAT Principal Bench order dated 3.11.2014 in above cited OA and MA's.

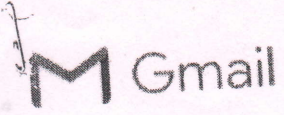
