**Respected Sir,**

We would like to draw your kind attention on the above cited subject and our letter under reference. In this regard, we would like to reiterated and submitted that-

- i) The APARs and VCRs have been called for almost 20 months back by the Personal Branch of BSNL Corporate Office in respect of the eligible JTOs of Telecom Factory Wing to fill up 16 numbers of SDE (TF) 'the then' vacant Posts on Promotion. Screening Committee report for the conduction of CPC to fill up 16 numbers of SDE (TF) vacant Posts has been forwarded by the TF Cell, BSNL Corporate Office to the Personal Branch of BSNL Corporate Office 15 months back. But the CPC process has not been initiated till date.
- ii) The APARs and VCRs have also been called before one year back by the Personal Branch of BSNL Corporate Office in respect of the eligible SDEs of Telecom Factory Wing to fill up 5 numbers of AGM (TF) vacant Posts on Promotion. But the CPC process has not been initiated till date for AGM (TF).

The abnormal delay in the issuance of SDE(TF) and AGM(TF) promotion orders caused demoralization, de-motivation, humiliation and serious heart burning among the Executives of Telecom Factory Wing.

**We would, therefore, requeste your good self to kindly intervene in this matter and cause to issue necessary instructions to the officers concerned for the immediate conduction of CPCs in the Telecom Factory Wing and early issuance of promotion orders for the above said vacant Posts in TF Wing for SDE (TF) and AGM (TF) so as to motivate the Executives of Telecom Factory Wing.**
