It is constrained to bring to your kind Notice that Ten Executives who have already been working as SDEs from 12.11.2008 onwards as per the LDCE Promotion order dated 03.11.2008 were erroneously included in the recent JTO(T) to SDE(T) promotion order issued on 8.7.2021 by the BSNL CO vide the above cited ref (1).

The affected Executives have submitted representations to the Pers.Branch, BSNL Corporate Office, New delhi requesting removal of their names from the Promotion List since they have already been working as SDE from 12.11.2008 onwards. But till date their names have not been removed from the Promotion List.

Sir, In this regard it is submitted that the reversion orders dated 06.9.2019 of 39 SDEs who have been promoted through LDCE -2007 has been discussed with the Management, Director(HR), the then PGM(Pers) BSNL CO and Committee members several times from 21.9.2019 to 11.10.2020 by the AIBSNLEA CHQ Team and we had a detailed discussion with the Committee Members on 19.5.2020 and submitted our views before the Committee.

We appraised the Committee and the Management that the reversion of the 2001 JTOs could have avoided as all of them are eligible as per the Schedule 12, Note 5 of the SDE RR 2002 read with the clarifications issued by BSNLCO dated 16.04.2007 and 10.07.2007 and the Management allowed them to appear for LDCE 2007 –SDE(T) after scrutiny of their eligibility and also promoted them in SDE Grade. **Considering the merit of the case, we requested the Management that their Service in SDE Grade since 2008 will remain intact and they may not be reverted and the issue will be settled as one time measure and render justice to these executives.**

Finally, the reversion orders dated 06.9.2019 of 39 SDEs who have been promoted through LDCE -2007 has kept in abeyance after the Committee Recommendation and as per the approval of Competent Authority on 12.10.2020 vide the above cited refernce at (5) and they will continue to act as SDEs till the disposal of Review Petitions (WMP.Nos. 30392, 30942, 30943 &30936 of 2019) pending before Hon'ble Madras High Court.

In view of the foregoing facts, we would request your goodself to kindly intervene in the matter and cause to issue necessary instructions to the Officer concerned to remove/cancel the above said 10 names of the SDEs appeared in the Promotion order dated 8.7.2021 so as to mitigate their sufferings and render justice.
