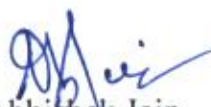
We submitted the case of Shri S. Subramanian(HR no-199800271), JAO, Nagercoil BA, Tamil Nadu Circle, regarding his pending promotion.

As per Ref. 1, the SEA Section, BSNL Corporate Office, had issued his promotion order, based on which Tamil Nadu Circle released the corresponding order vide Ref. 2. Unfortunately, due to a third-party complaint of a malafide and baseless nature, his vigilance clearance was withheld, and consequently, he could not avail of the said promotion.

It is pertinent to mention that the case was censured by the reviewing authority in 2019, and no further vigilance issues are pending against him. Despite this, Shri S. Subramanian has not yet been promoted to the grade of Accounts Officer (AO).

- All the above executives who have been considered for promotion to grade of Accounts Officer on the basis of ACR/APAR grading furnished by the concerned Circles. The promotion orders are subject to the condition that the Executives are free from Vigilance angle. All the concerned Circles, are, therefore requested to ensure that the Vigilance status of the above mentioned Executives posted in their concerned Circles before implementing the promotion is obtained and should be free from any disciplinary/vigilance case of type referred to in DOP&T OM No. 22011/4/91-Estt (A) dated 14.09.1992 or any currency of punishment. In such cases, he/ she should not be promoted and the matter should reported to this office immediately without fail. In cases where any of the above mentioned conditions are met resulting in non promotion of the executive, the same may be immediately brought to the notice of BSNL (SEA Branch) alongwith complete and supporting details.
- On promotion to the grade of Accounts Officer the pay of the Executives will be fixed as per the instructions issued vide OM no. 1-50/2008-PAT(BSNL) dated 05.03.2009 read with letter no. 400-61/2004-Pers.I dated 18.01.2007 and further modifications issued from time to time if otherwise applicable.
- If the Executives are on leave/training, they shall be promoted after return from such leave/training.
- In case of any discrepancies, viz. Correction in the name of the Executive, Staff No., Category etc shown in the order, the same may be brought to the notice of BSNLCO with supporting documents for rectification of records. Moreover, if the Executives are not working in the respective Circle shown against them, the same may also be informed to BSNL CO.
- Posting of executive (s) to the sensitive/non-sensitive posts should be done by the Circle as per prescribed norms circulated by DoT and O&M branch of BSNL Corporate Office from time to time.
- After implementation of these promotion orders, administration reserves the right to transfer any executive considering the administrative exigencies and availability of vacancies.
- All the Circle IFAs may intimate to DGM (SEA) BSNL CO, the up-to- date position regarding the vacancies in the grade of AO/Sr. AOs in their Circles after implementation of these orders.

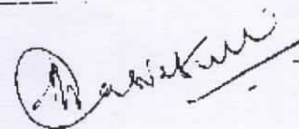
