Subject: Reservation for the Persons with Benchmark Disabilities in Direct Recruitment for JTO(T) and JE Cadre-reg.

Sir,

Kind reference is invited to Gazette Notification of the Rights of Persons with Disabilities Act 2016 passed by Parliament and endorsed by DoP&T OM no. 36035/02/2017-Estt(Res) dated 15.01.2018 and DoT letter no. 17-1/2018-SCT dated 01.02.2018 and further endorsed by BSNL CO. SCT cell vide letter no.28-6/2017-SCT(Part-1)/06 dated 21.02.2018.

The above said Gazette Notification inter alia vide Chapter VI para 34(1) stipulates as under:

Every appropriate Government shall appoint in every Government establishment not less than FOUR percent of the total number of vacancies in the cadre strength in each group of posts meant to be filled with persons with benchmark disabilities of which, one percent each shall be reserved for persons with benchmark disabilities under clauses(a), (b) and (c) and one percent for persons with benchmark disabilities under clauses (d) and (e) namely:

(a) Blindness and low vision;

(b) Deaf and hard of hearing;

- (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy;
- (d)Autism , intellectual disability, specific learning disability and mental illness;
- (e) Multiple disabilities from amongst persons under clauses (a) to (d) including deaf- blindness in the posts identified for each disabilities.

In this regard, it is pertinent to mention that as per PWD act 1995, BSNL is providing 3% reservation to PWD candidates vide DoT

order dated 21.04.2003, in which **1.5%** is given to LOCOMOTIVE IMPAIRED candidates and **1.5%** is given to HEARING IMPAIRED candidates and no provision has been made for Visually impaired in JTO(T) & JE cadres because these cadres are Technical Cadres.

As BSNL has already identified the TWO category(i.e HEARING & LOCOMOTIVE IMPAIREDMENT) to which reservation is given , hence Competent authority has decided to redistribute 4% reservation to PWD candidates in the same categories in JTO & JE cadre , as mentioned in clause (b) and (c) as under;
